OAMIC's 133rd ANNUAL CONVENTION

February 15-17, 2012

EXHIBITOR INVITATION AND REGISTRATION

OAMIC invites you to join us as an exhibitor for its 133rd annual convention, February 15-17, 2012. OAMIC's members include insurers of all sizes, but are primarily composed of companies writing less than \$25 million in annual premiums.

The exhibit area will be located in the hotel lobby area (Upper Terrace) in close proximity to our meeting rooms. The Upper Terrace also serves as the reception and refreshment break areas. Exhibit area will be formally open from 4:00–6:30 p.m. on Wednesday, February 15th, and from 9:00–10:00 a.m. and 2:45–3:15 p.m. on Thursday, February 18th.

Exhibit space includes one table (3' X 6'), and two chairs. Tables will be covered and skirted but do not include drops or dividers.

Exhibit fee includes a convention registration for one exhibitor (includes all meals and functions). Additional exhibitor representatives must complete a convention attendee registration and submit it with the OAMIC Member registration fee of \$199 (convention attendee registration will be available online at www.oamic.org in November).

Exhibit Fees (includes one registration): \$450 (OAMIC Member) or \$750 (Non-Member)
Additional Exhibitor Fees (if more than one attending): \$199/person

Back again in 2012: all sponsors and exhibitors will be included on OAMIC's website in the 'Virtual Convention' section which will contain links back to your organization's site (2011 site <http://bit.ly/nEZfiS>).

Exhibit space is limited to 16 booths and will be assigned based on the date exhibitor registration payment is received (first-come/first-served basis). Exhibit space did sell out the past three years so be sure to submit your registration form and payment early to assure booth space. Electricity and WiFi will be provided at all booths.

To be an OAMIC exhibitor, complete the registration form (reverse side of this letter) and return it with payment by December 15, 2011. Forms and payment should be returned to OAMIC, 172 E. State Street, Suite 201, Columbus, OH 43215-4321.

We encourage you to bring a door prize to be presented during scheduled exhibitor hours.

If you require a sleeping room, the rate is \$102.00 plus taxes. Free guest-room high speed WiFi is available to convention sleeping room guests. If calling for a room, be sure to use OAMIC's group rate code "OAM" in order to obtain OAMIC's special room rate. The cutoff date for the reduced room rate is January 20, 2012.
